ORDER REGARDING DISTRIBUTION OF THE FINAL JUDGMENT

This matter came before the Court on the Class Plaintiff's Motion for Distribution of the Final Judgment, filed on April 21, 2017 along with the declaration of Steve Weisbrot, Esq. of Angeion Group. The Court reviewed the papers filed and conducted a hearing on this Motion on April 26, 2017, where the Court considered further discussion. The Court has also overseen these proceedings, including presiding over a liability trial, two (2) damages trials as well as extensive motion practice and is otherwise fully advised in the premises. Accordingly, the Court hereby finds and orders as follows:

- (1) Class Plaintiff's Motion for Distribution of the Final Judgment is **GRANTED**.
- (2) After twelve (12) years of litigation, this matter generated, for the Class, a total recovery of \$21,271,056.63 (the "Final Distribution").
- (3) The Class shall be compensated no less than the full amount of tank rent charged, including sales tax, for the damages specifically identified in this Court's Final Judgment, which was Per Curiam Affirmed on appeal. Each Class members' individual damages are reflected in the spreadsheets entered into evidence at the damages trials, which Angeion Group will utilize. For

concluding the administration and distribution process, Angeion Group shall be paid the sum of \$64,941.00, as detailed in Exhibit "A" to the Plaintiff's Motion for Distribution of the Final Judgment filed April 21, 2017.

- (4) The Final Distribution is to begin forthwith.
- (5) The Court has separately ordered that Class Plaintiff's Counsel be paid attorneys' fees and reimbursed expenses and that Class Plaintiff be compensated from the Final Distribution in the total, collective sum of \$9,928,419.64. See Order Regarding Distribution of Attorney's Fees and Costs to Class Counsel from the Common Fund.
- (6) Class Plaintiff is ordered to provide the Court with a status report regarding the progress of the Final Distribution, whether any Class members object to the Court's Order Regarding Distribution of Attorney's Fees and Costs to Class Counsel from the Common Fund, and to account for any Class members' checks, which are not timely negotiated within 90 days from the date of this Order.
